

ORDINANCE NO. 228

AN ORDINANCE OF THE CITY OF CLARK FORK, IDAHO, AMENDING ORDINANCE NO. 227, THE APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2001 AND ENDING SEPTEMBER 30, 2002; APPROPRIATING ADDITIONAL MONIES IN THE SUM OF \$7,250.00 FROM A CITY SAVINGS ACCOUNT AND \$2,854.00 THAT HAS BEEN RECEIVED BY THE CITY OF CLARK FORK, IDAHO IN A STATE GRANT; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF CLARK FORK, IDAHO:

SECTION 1: That Ordinance No. 227, the appropriation ordinance for the City of Clark Fork, Idaho, for the fiscal year commencing October 1, 2001, and ending September 30, 2002, is hereby amended as follows:

That the additional sum of \$2,854.00 received from an Idaho Department of Lands Grant be appropriated out of the revenues in the General Fund to be used to purchase radios for the Clark Fork Volunteer Fire Department; and

That the additional sum of \$7,250.00 be appropriated from the City's Water Fund savings account to be used to pay off water loan #01-0279303 currently owed to GMAC Commercial Mortgage Corporation.


SECTION 2: This ordinance shall be in full force and effect from and after its passage, approval and publication.

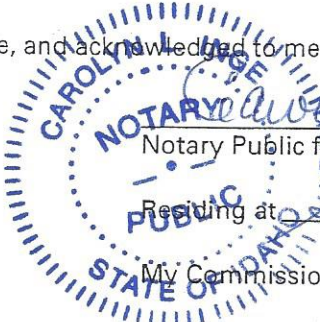
