AN ORDINANCE OF THE CITY OF CLARK FORK, IDAHO, AMENDING ORDINANCE NO. 239, THE APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2004 AND ENDING SEPTEMBER 30, 2005, APPROPRIATING ADDITIONAL MONIES FROM REVENUE SHARING - STATE OF IDAHO IN THE SUM OF \$ 4,700.00; FIRE DEPARTMENT REVENUE IN THE SUM OF \$4,000.00 AND FROM CITY SAVINGS ACCOUNT IN THE SUM OF \$53,700.00, AND PROVIDING AN EFFECTIVE DATE.
