

CLARK FORK ORDINANCE NO. 244-1

AN ORDINANCE OF THE CITY OF CLARK FORK, IDAHO, AMENDING ORDINANCE NO. 244, THE APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2005 AND ENDING SEPTEMBER 30, 2006, APPROPRIATING ADDITIONAL REVENUE RECEIVED IN THE SUM OF \$20,980.00 AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Mayor and City Council of the City of Clark Fork, Idaho.

Section 1: That Ordinance No. 244, the appropriation ordinance for the City of Clark Fork, Idaho, for the fiscal year commencing October 1, 2005, and ending September 30, 2006, be and the same is hereby amended as follows:
