

CLARK FORK ORDINANCE NO. 247-1

AN ORDINANCE OF THE CITY OF CLARK FORK, IDAHO, AMENDING ORDINANCE NO. 247, THE APPROPRIATIONS ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2006 AND ENDING SEPTEMBER 30, 2007, APPROPRIATING ADDITIONAL MONIES RECEIVED BY THE CITY OF CLARK FORK, IDAHO, IN THE SUM OF \$183,293 AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Mayor and City Council of the City of Clark Fork, Idaho.


Section 1. That Ordinance No. 247, the appropriations ordinance for the City of Clark Fork, Idaho, for the fiscal year commencing October 1, 2006, and ending September 30, 2007, be and the same is hereby amended as follows:

That the additional sum of \$183,293 be appropriated out of the following revenues, to be used for authorized activities:


General Fund - Grant Income	\$ 167,000
General Fund - Interest Income	\$ 6,200
General Fund - Animal Control Fees	\$ 800
General Fund - Miscellaneous	\$ 200
Street Fund - Interest Income	\$ 4,576
Water Fund - Interest Income	\$ 4,517

Section 2. This ordinance shall take effect and be in full force and effect from and after its passage, approval and publication.
