ANNUAL APPROPRIATIONS ORDINANCE FOR 1977 FOR THE CITY OF CLARK FORK, IDAHO

AN ORDINANCE OF THE CITY OF CLARK FORK FOR THE PURPOSE OF APPRO-PRIATING SUCH SUM OR SUMS OF MONEY AS MAY BE REQUIRED TO DEFRAY ALL NECESSARY EXPENSES AND LIABILITIES OF THE CITY OF CLARK FORK, MOT OTHERWISE PROVIDED FOR, FOR THE PERIOD JANUARY THRU SEPTEMBER 1977; WHICH EXPENSES AND LIABILITIES ARE IN THE SUM OF \$56,783.00, AND DOES NOT EXCEED THE TOTAL AMOUNT OF THE PREPARED AND APPROVED BUDGET. IN ADDITION TO ALL OTHER ANTICIPATED REVENUES OF THE CITY AND MONEYS ON HAND IT WILL BE NECESSARY TO RAISE \$14,203.00 FROM TAXES ASSESSED ON ALL TAXABLE PROPERTY WITHIN THE CITY OF CLARK FORK. ALL APPROPRIATIONS FOR THE PERIOD JANUARY THRU SEPTEMBER 1977 ARE MORE PARTICULARLY SET FORTH AND DESCRIBED AS TO THE AMOUNT, OBJECT AND PURPOSE AS FOLLOWS: APPROPRIATING THE SUM OF \$28,422.00, \$9,090.00 OF WHICH IS TO BE RAISED FROM TAXES, FOR THE GENERAL FUND; APPROPRIATING THE SUM OF \$16,161.00, \$5,113.00 OF WHICH IS TO BE RAISED FROM TAXES FOR MAINTAINING CITY STREETS AND STREET LIGHTING; APPROPRIATING THE SUM OF \$12,200.00 FOR THE PURPOSE OF MAINTENANCE OF THE CITY WATER SYSTEM; PROVIDING FOR A COPY OF THIS ORDINANCE TO BE FILED WITH THE BONNER COUNTY AUDITOR, IDAHO STATE TAX COMMIS-SION AND THE IDAHO SECRETARY OF STATE; AND PROVIDING FOR PUBLI-CATION OF THIS ORDINANCE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF CLARK FORK, IDAHO:

Section 1: There is hereby appropriated for the purpose of defraying all necessary expenses and liabilities of the City of Clark Fork, for the period January thru September 1977, the sum of \$56,783.00, said appropriations to be used for the following objects and purposes, and in the following amounts, to wit:
