## ANNUAL APPROPRIATIONS ORDINANCE FOR FISCAL YEAR BEGINNING OCTOBER 1, 1981 FOR THE CITY OF CLARK FORK, IDAHO

AN ORDINANCE OF THE CITY OF CLARK FORK FOR THE PURPOSE OF APPRO-PRIATING SUCH SUM OR SUMS OF MONEY AS MAY BE REQUIRED TO DEFRAY ALL NECESSARY EXPENSES AND LIABILITIES OF THE CITY OF CLARK FORK, NOT OTHERWISE PROVIDED FOR, FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 1981; WHICH EXPENSES AND LIABILITIES ARE IN THE SUM OF \$ 102, 600.00, AND DOES NOT EXCEED THE TOTAL AMOUNT OF THE PREPARED BUD-GET. IN ADDITION TO ALL OTHER ANTICIPATED REVENUE OF THE CITY AND MONEYS ON HAND IT WILL BE NECESSARY TO RAISE \$18,643.00 FROM TAXES ASSESSED ON ALL TAXABLE PROPERTY WITHIN THE CITY OF CLARK FORK. ALL APPROPRIATIONS FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 1981 ARE MORE PARTICULARLY SET FORTH AND DESCRIBED AS TO THE AMOUNT, OBJECT AND PURPOSE AS FOLLOWS: APPROPRIATING THE SUM OF \$31,300.00, \$11,932.00 OF WHICH IS TO BE RAISED FROM TAXES, FOR THE GENERAL FUND; APPROPRIATING THE SUM OF \$25,500.00, \$6,711.00 OF WHICH IS TO BE RAISED FROM TAXES FOR MAINTAINING CITY STREETS AND STREET LIGHTING; APPROPRIATING THE SUM OF \$13,800.00 FOR THE PURPOSE OF MAINTENANCE OF THE CITY WATER SYSTEM; PROVIDING \$3,500. OO FOR EQUIPMENT REPLACEMENT; PROVIDING \$3,500.00 FOR SOLID WASTE BURIAL; PROVIDING \$25,000.00 FOR CAPITAL IMPROVEMENT AND PROVIDING FOR A COPY OF THIS ORDINANCE TO BE FILED WITH THE BONNER COUNTY AUDITOR, AND PROVIDING FOR PUBLICATION OF THIS ORDINANCE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF CLARK FORK, IDAHO:

Section 1: There is hereby appropriated for the purpose of defraying all necessary expenses and liabilities of the City of Clark Fork, for the fiscal year beginning October 1, 1981, the sum of \$102,600.00, said appropriations to be used for the following objects and purposes, and in the following amounts, to wit:
