

ANNUAL APPROPRIATIONS ORDINANCE FOR THE FISCAL YEAR
 BEGINNING OCTOBER 1, 1986 FOR THE CITY OF
 CLARK FORK, IDAHO

AN ORDINANCE OF THE CITY OF CLARK FORK FOR THE PURPOSE OF APPROPRIATING SUCH SUM OR SUMS OF MONEY AS MAY BE REQUIRED TO DEFRAY ALL NECESSARY EXPENSES AND LIABILITIES OF THE CITY OF CLARK FORK NOT OTHERWISE PROVIDED FOR; FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 1986; WHICH EXPENSES AND LIABILITIES ARE IN THE SUM OF \$103,046. AND DOES NOT EXCEED THE TOTAL AMOUNT OF THE PREPARED BUDGET. IN ADDITION TO ALL OTHER ANTICIPATED REVENUE OF THE CITY AND MONEYS ON HAND IT WILL BE NECESSARY TO RAISE \$~~40,3~~³838.00 FROM TAXES ASSESSED ON ALL TAXABLE PROPERTY WITHIN THE CITY OF CLARK FORK. ALL APPROPRIATIONS FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 1986 ARE MORE PARTICULARLY SET FORTH AND DESCRIBED AS TO THE AMOUNT, OBJECT AND PURPOSE AS FOLLOWS: APPROPRIATING THE SUM OF \$45,593.00; \$16,334. OF WHICH IS TO BE RAISED FROM TAXES, FOR THE GENERAL FUND: APPROPRIATING THE SUM OF \$29,201.00; \$14,504.00 OF WHICH IS TO BE RAISED FROM TAXES FOR MAINTAINING CITY STREETS AND LIGHTING: APPROPRIATING THE SUM OF \$21,898.00 FOR THE PURPOSE OF MAINTENANCE OF THE CITY WATER SYSTEM: PROVIDING \$3,500.00 FOR EQUIPMENT REPLACEMENT: PROVIDING \$3,000.00 FOR SOLID WASTE BURIAL: PROVIDING FOR A COPY OF THIS ORDINANCE TO BE FILED WITH THE BONNER COUNTY AUDITOR, AND PROVIDING FOR PUBLICATION OF THIS ORDINANCE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF CLARK FORK, IDAHO:

Section 1: There is hereby appropriated for the purpose of defraying all necessary expenses and liabilities of the City of Clark Fork, for the fiscal year beginning October 1, 1986, the sum of \$103,046.00, said appropriations to be used for the following objects and purposes, and in the following amounts, to wit:

Section 2: In order to meet the demands of the approved budget for fiscal year beginning October 1, 1986 as set forth, the City Council of Clark Fork has determined, and hereby certifies to the Bonner County Commissioners, that the total amount of money required and necessary to be raised from taxes on all property within the Clark Fork city limits, for all purposes, for the fiscal year beginning October 1, 1986 is in the amount of \$40,838.00 (forty thousand, eight hundred thirty eight and no dollars).

Section 3: This ordinance shall take effect and be in full force and effect upon its passage, approval and publication.

Passed under suspension of the rules upon which a roll call vote was duly taken and duly enacted as an ordinance of the City of Clark Fork at a special meeting of the City Council held August 26, 1986.
