

CLARK FORK ORDINANCE NO. 258

AN ORDINANCE OF THE CITY OF CLARK ENTITLED THE ANNUAL APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2011 AND ENDING SEPTEMBER 30, 2012; APPROPRIATING THE SUM OF \$352,086 TO DEFRAY THE EXPENSES AND LIABILITIES OF THE CITY OF CLARK FORK FOR SAID FISCAL YEAR; AUTHORIZING A LEVY OF A SUFFICIENT TAX UPON THE TAXABLE PROPERTY; AND SPECIFYING THE OBJECTS AND PURPOSES FOR WHICH SAID APPROPRIATION IS MADE.

BE IT ORDAINED by the Mayor and City Council of the City of Clark Fork, Bonner County, Idaho.

Section 1: That the sum of \$352,086 be, and the same is appropriated to defray the necessary expenses and liabilities of the City of Clark Fork, Bonner County, Idaho for the fiscal year beginning October 1, 2011.

Section 2: The objects and purposes for which such appropriation is made, and the amount of each object and purpose is as follows:

<u>ESTIMATED EXPENDITURES:</u>	
GENERAL FUND:	\$190,174
STREET FUND:	\$ 74,728
WATER FUND:	\$ 87,184
TOTAL EXPENDITURES	<u>\$352,086</u>

Section 3: That a general tax levy of \$57,000 on all taxable property within the City of Clark Fork be levied for the general purposes of said City, for the fiscal year beginning October 1, 2011.


Section 4: All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

Section 5: This ordinance shall take effect and be in full force upon its passage, approval and publication in one issue of the Bonner County Daily Bee, a newspaper of general circulation in the City of Clark Fork, and the official newspaper of said City.
