

ORDINANCE No.121

1 AN ORDINANCE TO INCLUDE WITHIN AND ADD TO THE LIMITS OF THE VILLAGE OF CLARK
2 FORK, IDAHO, CERTAIN TERRITORY CONTIGUOUS OR ADJACENT THERETO AND WHICH TERRITORY
3 IS MORE PARTICULARLY DESCRIBED IN THIS ORDINANCE, AND PROVIDING FOR PUBLICATION
4 OF THIS ORDINANCE.

5 BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF CLARK
6 FORK, IDAHO:

7 Section 1. That under and by virtue of the laws of the State of Idaho,
8 the following described territory contiguous or adjacent to the corporate limits
9 of the Village of Clark Fork, in the County of Bonner, State of Idaho, is hereby
10 annexed, added to, and included within the corporate limits of said Village,
11 to-wit:

12 Commencing at a point where the South-easterly limits of the present
13 limits of the Village of Clark Fork intersect the northerly line of
14 U.S.Highway No.10A; thence South-easterly along the northerly line of
15 said U.S.Highway No.10A to a point where the section line between
16 Sections 27 and 28 Township 55 North Range 3 E.B.M. intersects the
17 said North line of said U.S.Highway No.10A; thence along the North
18 line of said highway 2693 feet, more or less, to a point; thence North
19 $52^{\circ} 43'$ East 130 feet; thence North $37^{\circ} 17'$ West 110 feet; thence
20 South $52^{\circ} 43'$ West 100 feet; thence South $37^{\circ} 17'$ East 110 feet;
21 thence South $52^{\circ} 43'$ West 30 feet to the North line of U.S.Highway
22 No.10A; thence North-westerly following the said right-of-way line
23 to the place of beginning, the present village limits of the Village
24 of Clark Fork, Idaho.

25 Section 2. This Ordinance shall be in full force and effect from and
26 after its publication, as provided by law, in the Sandpoint News-Bulletin, a
27 weekly newspaper of general circulation in the Village of Clark Fork, Idaho,
28 which is hereby designated as the official newspaper of the Village for the
29 publication of this Ordinance.

30 Passed under suspension of the statutes and rules and duly enacted as an
31 Ordinance of the Village of Clark Fork, at a regular meeting of the Board of
32 Trustees of the Village of Clark Fork, held on the 4th day of June, 1951.
