

ORDINANCE NO. 57.

BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF CLARKS FORK:

SECTION 1. That any lot, part of lots or lots or land in the Village of Clarks Fork which has now or may hereafter have any connection or connections with the water system of the Village of Clarks Fork shall be held accountable from the time this ordinance shall take effect for the rent to become due under the regular schedule of rates fixed by the Board of Trustees of the Village of Clarks Fork for all water used on said premises or elsewhere from the connection or connections on said premises with said water system.

SECTION 2. That the water rent for the use of water on any premises from said connection or connections on said premises shall be paid in advance, by the month, on or before the 10th day of each month and such rent may be paid by the tenant renting or leasing said premises or by the owner thereof.

SECTION 3. The Village Clerk shall keep an accurate account of all rentals due for water from said water system according to the schedule of rates fixed by the Board of Trustees of the Village of Clarks Fork for water rent, and the premises on which said connection or connections are located, and shall make a return of all delinquent payments of water rent, together with the description of the premises, to the Village Trustees within the first quarter of each fiscal year and the Chairman and Board of Trustees shall, at the time of levying the taxes for general village purposes for said year, levy the amount of any delinquent water rentals on any premises, to each lot, part of lot or lots or land as a special tax against the same and such special assessment shall be certified to the County Auditor and the same shall be levied and collected in all respects like any other city taxes upon real estate. No lot, part of lot or lots or land shall be exempt from the payment of such special taxes.

SECTION 4. That the Board of Trustees of the Village Clerk shall have the power to turn off the water from any premises where the water rent is delinquent and demand the payment of such delinquent rent together with a fee of One Dollar as the conditions on which the water will be again turned on for said premises. The Board of Trustees shall also levy such delinquent rent against such premises as hereinbefore provided if such delinquent rent has not been paid prior to the time of making such levy.

SECTION 5. This ordinance shall take effect and be in force from and after its passage, approval and publication in one issue of the Pend d'Oreille Review, a weekly newspaper of general circulation in the Village of Clarks Fork, printed and published in Sandpoint, Idaho, said paper being designated as the official newspaper of the Village of Clarks Fork for the publication of this ordinance.

Passed under suspension of the statutes and rules and duly enacted as an ordinance of the Village of Clarks Fork at a regular meeting of the Board of Trustees held Nov 7, 1921.
