

ORDINANCE NO. 99

AN ORDINANCE PURSUANT TO SECTION 49-1147 IDAHO CODE ANNOTATED RELATIVE TO THE REMOVAL OF WEEDS, GRASS, RUBBISH, DISEASES, PESTS AND OTHER PROPERTY INJURIOUS TO PERSONS AND PROPERTY AND PROVIDING FOR THE COLLECTION OF MONIES FOR THE COST OF SUCH REMOVAL

BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF CLARKS FORK, IDAHO.

Section 1. It shall be the duty of all owners, tenants or occupants of premises abutting or adjoining any sidewalk or alley within the corporate limits of Clarks Fork, Idaho to cut and remove all weeds, grass and rubbish and to eradicate any diseases or pests, eggs, larvae of any pests injurious to trees, plants, shrubs or vines upon said private property to the center of any alley along or in front of said property, including the parking within the curbing abutting such property, within ten days from the time of notice by the Board of Trustees so to do served upon said owner, tenant or occupant in writing as prescribed hereafter.

Section 2. Whenever it appears to the Village of Clarks Fork and to the Board of Trustees thereof that for the purpose of fire protection and for health purposes that such weeds, grass and rubbish should be removed or that it is necessary to eradicate any diseases, pests, eggs, larvae of any pests injurious to trees, plants, shrubs or vines, upon resolution of the Board of Trustees it shall be the duty of the Village Clerk to serve notice in writing upon such owner, tenant or occupant to remove said weeds, rubbish and grass or to eradicate any diseases, pests, eggs, larvae of any pests injurious to trees, plants, shrubs or vines within ten days from the receipt of such notice. If no owner, tenant or occupant can be found who shall be entitled to such notice and his residence be not known the Village Clerk shall cause to be posted upon said property a written notice directing said removal as aforesaid.

Section 3. In the event of the failure of any such owner, tenant or occupant of premises to remove such rubbish or to cut

or remove the weeds, rubbish and grass and to eradicate any diseases, pests, eggs, larvae of any pests injurious to trees, plants, shrubs or vines after said ten days written notice then, in that event the Village of Clarks Fork and its officers and employees are empowered to remove such weeds, rubbish, grass and eradicate any diseases, pests, eggs, larvae of any pests injurious to trees, plants, shrubs or vines and assess the cost thereof against the premises. Such assessment shall be certified by the Village Clerk to the County Assessor of Bonner County, Idaho, such assessment to be placed upon the assessment roll and collected in the same manner as other municipal taxes are collected.
