A RESOLUTION OF THE CITY COUNCIL OF CLARK FORK, IDAHO, SETTING FORTH THE RATES, CHARGES & FEES FOR FIRE DEPARTMENT INSPECTIONS OUTSIDE THE CITY LIMITS AND FIRE SUPPRESSION SERVICE FOR NON-SUBSCRIBERS OUTSIDE THE CITY LIMITS.

WHEREAS the City of Clark Fork has enacted Ordinance No. 231 establishing a Fire Department;

AND WHEREAS the City of Clark Fork has also enacted Ordinance No. 241 adopting the International Fire Code which sets requirements for certain inspections by the fire code official;

AND WHEREAS the City of Clark Fork has also enacted Resolution 1-2005 which authorizes the Fire Department to leave the City Limits to respond to motor vehicle accidents and/or fires;

AND WHEREAS the City Fire Department incurs costs in performing these inspections and fire suppression services;

NOW THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Clark Fork, Idaho that the following fees and regulations shall apply for services outside the city limits:

1. Residential and Commercial Properties and Subdivisions Review.

a. Annexation, contracts, zoning change applications and conditional use permits (one time fee):

\$50.00

b. Preliminary Plot and Planned Development for 2-9 lots: \$50.00 plus \$1.00 per lot Preliminary Plot and Planned Development for over 9 lots: \$250.00 plus \$1.00 per lot

c. Final Plot \$50.00

2. Commercial Plan Review and Inspection Fees.

a. Fire Sprinkler Plan Review	\$150.00
b. Fire Alarm Plan Review	\$150.00
c. Day Care Inspection	\$ 30.00
d. Residential Location Inspection	\$ 30.00
e. Commercial Location Inspection	\$ 35.00
