

RESOLUTION NO. 1-2012  
CITY OF CLARK FORK, IDAHO

A RESOLUTION OF THE CITY COUNCIL OF CLARK FORK, IDAHO SETTING FORTH THE WATER USER CHARGES AND THE CONNECTION FEES FOR THE CITY OF CLARK FORK, IDAHO.

WHEREAS the City Council of the City of Clark Fork has passed Water Ordinance No. 251.

AND WHEREAS Ordinance No. 251 specifies that all rates, charges and fees will be set by resolution;

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF CLARK FORK, IDAHO THAT: All owners or agents must make application for connection to the water system on a form provided by the city and the owner or agent therefore of all properties connecting to the water system under the terms of this Ordinance of the City shall pay the following rates, charges and fees for the services provided. All other users will require special appraisal and will be computed on an individual basis.

A. WATER USAGE CHARGES

1. Residential

Base Rate:

\$17.79 per month per user

Every user will pay this base rate whether water is used or not.

NOTE: Each residence, mobile home or business supplied with water from a meter is considered a separate user. There may be more than one user on a meter.

User Charge:

\$1.36 per each 1,000 gallons

This charge is in addition to the base rate charge to all customers using water based on the meter reading.

2. Commercial

Base Rate: (per meter size per month)

	<u>Meter Size</u>
\$24.22	$\frac{3}{4}$ inch
\$32.06	1 inch
\$87.50	2 inch
\$218.75	3&4 inch

User Charge:

\$1.36 per each 1,000 gallons

This charge is in addition to the base rate charge to all customers using water based on the meter reading.

3. Use of Water from Fire Hydrants

Water taken from fire hydrants for purposes other than use by the Fire Department:

\$12.00 per each 1,000 gallons

B. DELINQUENT FEE

Failure to pay water charges within 30 days of due date:

\$20.00

C. CONNECT AND DISCONNECT FEES

Customer requested connects and disconnect of service during non-business hours.

(Water turn-on or turn-off at meter)

1. Connect Fee:

\$25.00

2. Disconnect Fee:

\$25.00

No charge for connects or disconnect during normal business hours.

D. WATER METER INSTALLATION AND SERVICE CONNECTION FEES

A non-refundable deposit of 10% of the connection fee is required at time of application. Deposit will be applied to installation fee at time of full payment.

(per meter size)	<u>Meter Size</u>
\$5,000.00	1 inch
\$6,500.00	2 inch
\$8,500.00	3 inch
\$12,500.00	4 inch

The City shall provide the meter, meter box, connection to the main, corporation stop and other materials as required. The full fee MUST be paid prior to installation.

E. FIRE SERVICE CONNECTION FEE

A non-refundable deposit of 10% of the connection fee is required at time of application. Deposit will be applied to installation fee at time of full payment.

\$8500.00 -- up to a 4 inch connection.

Larger connections will be addressed on an as need basis.

F. PRIVATE WATER SYSTEM

Permit and Inspection Fee:

\$100.00

Water meters will be read at the end of each month and billing will be mailed to customers on the first day of each quarter. No credit will be given for water lost due to leakage of the property owners system.


