

**RESOLUTION NO. 2-2008  
CITY OF CLARK FORK, IDAHO**

TITLE: Fire Department Inspection Fees Outside the City Limits and Fire Suppression Fees for Non-Subscribers Outside the City Limits.

A RESOLUTION OF THE CITY COUNCIL OF CLARK FORK, IDAHO, SETTING FORTH THE RATES, CHARGES & FEES FOR FIRE DEPARTMENT INSPECTIONS OUTSIDE THE CITY LIMITS AND FIRE SUPPRESSION SERVICE FOR NON-SUBSCRIBERS OUTSIDE THE CITY LIMITS.

WHEREAS the City of Clark Fork has enacted Ordinance No. 231 establishing a Fire Department;

AND WHEREAS the City of Clark Fork has also enacted Ordinance No. 241 adopting the International Fire Code which sets requirements for certain inspections by the fire code official;

AND WHEREAS the City of Clark Fork has also enacted Resolution 1-2005 which authorizes the Fire Department to leave the City Limits to respond to motor vehicle accidents and/or fires;

AND WHEREAS the City Fire Department incurs costs in performing these inspections and fire suppression services;

NOW THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Clark Fork, Idaho that the following fees and regulations shall apply for services outside the city limits:

1. Residential and Commercial Properties and Subdivisions Review.
  - a. Annexation, contracts, zoning change applications and conditional use permits (one time fee): \$100.00
  - b. Preliminary Plot and Planned Development for 2-10 lots: \$100.00 plus \$50.00 per lot  
Preliminary Plot and Planned Development for over 10 lots: \$200.00 plus \$50.00 per lot
  - c. Final Plot \$50.00
2. Commercial Plan Review and Inspection Fees.
  - a. Fire Sprinkler Plan Review \$ 50.00
  - b. Fire Alarm Plan Review \$ 50.00
  - c. Day Care Inspection \$ 48.00
  - d. Residential Location Inspection \$ 30.00
  - e. Commercial Location Inspection \$ 35.00
  - f. Fireworks Stand – Retail \$ 50.00
  - g. Fireworks Stand – Wholesale \$100.00
  - h. Special Permits, Reviews, and/or sign-off not listed above(1 hr minimum) \$ 30.00/hour


3. All commercial buildings will be required to have a Knox Box installed on them (the Fire Department will supply the forms to order it).
4. Apparatus and personnel **hourly** rates for Non-Subscribing residents and businesses for Fire Suppression Services.
 

a. Type 1-3 Engine	\$180.00
b. Type 4-7 Engine	\$ 80.00
c. Water Tender	\$130.00
d. Rescue Unit	\$100.00
e. Chief Officer and Command Vehicle	\$ 70.00
f. Fire Captain	\$ 40.00
g. Incident Commander below the rank of Captain	\$ 35.00
h. Firefighter	\$ 30.00
i. Driver/Operator	\$ 37.00
j. Trainee Firefighter	\$ 25.00
k. Special Application Apparatus (Breathing Air Support & Salvage)	\$ 50.00
l. Hazmat Operations (additional charge)	\$ 25.00

BE IT FURTHER RESOLVED THAT: This resolution shall replace Resolution No. 1-2007 in its entirety.

BE IT FURTHER RESOLVED THAT: This resolution shall be in full force and effect upon its passage and approval.
