

RESOLUTION NO. 2-2014  
CITY OF CLARK FORK, IDAHO

TITLE: ANIMAL CONTROL FEES, POLICIES AND PROCEDURES

WHEREAS the City of Clark Fork has enacted Animal Control Ordinance No. 262 which provides standards and procedures for care and ownership of animals within the City of Clark Fork;

WHEREAS Ordinance No. 262 provides for the setting of dog license and kennel license fees, adoption fees and other fees for the care and control of the impounding of animals;

AND WHEREAS the City has set animal control policies and procedures as listed below;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Clark Fork that:

The schedule of fees for animal control within the City of Clark Fork are hereby established as follows:

A. Annual dog licensing fees will be as follows:

1. Neutered Dogs - Ten (\$10.00) Dollars each
  2. Unneutered Dogs - Twenty (\$20.00) Dollars each
  3. Replacement Dog Licenses (Neutered & Unneutered Dogs) - Six (\$6.00) Dollars each
- The City may offer ½ price rates in December for the following year. There shall be no prorating of dog licensing fees.

B. Kennel license fees shall be:

1. Residential - \$75.00 for the first year and \$50.00 for each subsequent year.
2. Commercial - \$150.00 for the first year and \$100.00 for each subsequent year

If any kennel license is voided due to a violation of Ordinance No. 262, upon reapplication, and after verification by the city that the kennel has been brought into full compliance with Ordinance No. 262, the first year fee will again be required prior to reissuing of the kennel license.

Kennel licenses do not include dog licensing fees (must be purchased separately).

There shall be no prorating of Kennel licensing fees.

C. Adoption:

1. If the owner is unknown, any animal may be adopted after the 3rd day of impoundment.
2. If the owner is known, after the 5th day.
3. Adoption fees shall be \$5.00 plus License Fee, Impoundment Fee and a refundable deposit of \$40.00 for proof of rabies vaccination.  
(License fee and refundable deposit applicable to residents of Clark Fork only).
  - a. Rabies vaccination shall be obtained within 30 days of adoption.
  - b. Neutering shall be done within 30 days of adoption, or within 30 days of the date the dog becomes 6 months old.
  - c. Proof of vaccination and neutering shall be given to the City Clerk.
  - d. No refund of deposit after 30 days unless delayed by a Veterinarian.

D. Impoundment Service Fee:

- 1. Licensed animals - \$25.00 per week day. (or any part of a day)
  - a. Holidays and weekends - \$35.00 per day.
- 2. Non-Licensed animals - \$50.00 per week day. (or any part of a day)
  - a. Holidays and weekends - \$35.00 per day.

E. Humane Pickup Fee: \$10.00

F. After hours Pickup Fee: After normal business hours until 8:00 PM = \$40.00

- 1. Based on Animal Control Officer availability

G. Multiple Violation Enhanced Service Fee (same animal)

- 1. Second Offense: \$15.00
- 2. Third Offense: \$30.00
- 3. Fourth Offense: \$45.00
- 4. Fifth Offense: Abatement of the animal.

H. Special License Fee – Vicious Animal:

- 1. First Year Fee: \$250.00
- 2. Annual Renewal Fee: \$125.00
- 3. Liability Insurance: \$500,000.00
- 4. Inspection Fee: \$25.00


I. Non-Domestic Animal Permit:

- 1. First Year Permit Fee: \$250.00
- 2. Annual Renewal Permit Fee: \$125.00
- 3. Liability Insurance: \$500,000.00


BE IT FURTHER RESOLVED THAT this resolution replaces Resolutions 1-2006.
