TITLE: SETTING OF GARBAGE FEES AND GARBAGE COLLECTION DATE IN
THE CITY OF CLARK FORK, IDAHO

A RESOLUTION OF THE CITY COUNCIL OF CLARK FORK, IDAHO, SETTING FORTH
THE SCHEDULE OF FEES FOR GARBAGE COLLECTION; AND ALSO SETTING FORTH
THE DAY OF THE WEEK FOR GARBAGE COLLECTION.

WHEREAS the City Council of the City of Clark Fork has passed Garbage
Ordinance No. 197;

AND WHEREAS Ordinance No. 197 specifies that the schedule of fees for
garbage collection service shall be set forth by resolution;

AND WHEREAS Ordinance No. 197 specifies that the day of the week
scheduled for said garbage collection shall be set forth by
resolution;

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF
CLARK FORK, IDAHO THAT: The following is the Schedule of Fees for
garbage collection:

- a. Residential (standard garbage can type containers):
\$5.48 per month per residence for two garbage cans.
Each additional can is \$1.28.
 - b. Residential Senior Rate (standard garbage can type
containers): \$2.10 per month per residence for one
garbage can picked up once a month. A 2nd can is \$1.05.
 - c. Commercial (standard garbage can type containers):
\$6.30 per month for 1-5 cans per month. Each additional
can during the month is \$.85 per can.
 - d. Commercial (unit type containers):
 - (1) One-yard container - \$2.00 rental per month and
\$3.74 per pick-up.
 - (2) One & one half-yard container - \$3.00 rental per month
and \$4.56 per pick-up.
 - (3) Two-yard container - \$4.00 rental per month and
\$5.43 per pick-up.
 - (4) Three-yard container - \$6.00 rental per month and
\$7.02 per pick-up.
 - (5) Four-yard container - \$8.00 rental per month and
\$8.66 per pick-up.
 - (6) Six-yard container - \$12.00 rental per month and
\$10.87 per pick-up.
 - (7) Eight-yard container - \$16.00 rental per month and
\$13.07 per pick-up.

BE IT FURTHER RESOLVED THAT: The day of the week for garbage collection in the City of Clark Fork shall be Friday of each week with the following exceptions:

a. During weeks which include holidays which are observed by the garbage contractor, garbage service for the balance of the week following these non-worked holidays will be picked up one day late. Notification of holidays not worked shall be provided by the garbage contractor.

b. Residents using the Residential Senior Rate shall have their garbage picked up the first Friday of each month.

BE IT FURTHER RESOLVED THAT: This resolution shall be in full force and effect upon its passage and approval, and upon passage, approval and publication of Garbage Ordinance No. 197.
