

**RESOLUTION NO. 3-2009
CITY OF CLARK FORK, IDAHO**

A RESOLUTION OF THE CITY COUNCIL OF CLARK FORK, IDAHO, SETTING FORTH FEES FOR THE CLARK FORK VALLEY FIRE DEPARTMENT TO RESPOND TO AND SUPPLY AID TO MOTOR VEHICLE ACCIDENTS.

WHEREAS, the City Council of the City of Clark Fork has passed Ordinance No. 252; and

WHEREAS, Ordinance No. 252 specifies that said fees will be set by resolution; and

WHEREAS, after public hearing on March 9, 2009, regarding the new fees to respond to and supply aid to motor vehicle accidents, it is deemed by the city council that the proposed fees are the reasonable cost of providing the services and it is in the best interests of the city of Clark Fork and the citizens that the proposed fees which were addressed in the public hearing be adopted for the City of Clark.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF CLARK FORK, IDAHO:

Fees for the Clark Fork Valley Fire Department to respond to motor vehicle accidents will be as follows:

- A. Level 1
Traffic Control and Hazard Control.....\$395.00

- B. Level 2
Level 1 Services plus Cleanup and Hazmat Disposal (10 gallons or less).....\$600.00

- C. Level 3
Level 1-2 Services plus Fire Suppression, Breathing Apparatus Use and
Rescue Tool Use.....\$750.00


- D. Level 4
Level 1-3 Services plus Heavy Rescue Extrication.....\$1,400.00

- E. Level 5
Level 1-4 Services plus Mass Casualty and Multiple Vehicle Involvement.....\$2,100.00


- F. Add-Ons
Set-Up and Secure a Landing Zone.....\$295.00
Hourly Rate (billed in 15 minute increments) for each additional apparatus
and 2 personnel.....\$175.00
Major Hazmat Disposal (spills involving more than 10 gallons).....\$345.00
