## RESOLUTION 4-2014 CITY OF CLARK FORK, IDAHO

TITLE: SETTING OF FIRE SUPPRESSION AGREEMENT RATES, CHARGES & FEES.

A RESOLUTION OF THE CITY COUNCIL OF CLARK FORK, IDAHO SETTING FORTH THE RATES, CHARGES & FEES FOR THE FIRE SUPPRESSION SERVICE AGREEMENT MADE BETWEEN THE CITY OF CLARK FORK AND THE SUBSCRIBING PROPERTY OWNER/LESSEE.

**WHEREAS** the City Council of the City of Clark Fork has created and accepted the content of the Fire Suppression Agreement; and

WHEREAS certain rates, charges and fees are subject to periodic change; and

AND WHEREAS all rates, charges and fees shall be set by resolution;

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF CLARK FORK, IDAHO THAT:** the owner or agent therefore of all properties subscribing to fire suppression services from the City shall pay based upon the following schedule of subscriber fees.

#### A. SUBSCRIBER FEES

Base Fee: A \$75.00 Base Fee shall be collected yearly.

#### **Annual Fire Suppression Fee:**

- I. <u>Existing Structures</u>: A fee totaling .06% (.0006) of the Bonner County Assessor's Valuation of the structure shall be paid yearly or prorated according to Section B of this Resolution. If land coverage is also chosen to be protected, an additional fee totaling \$1.00 per acre shall be paid yearly or prorated according to Section B of this Resolution.
- II. Pre & New Construction: For structures not yet completed and that do not yet have a Valuation of the structure given by the Bonner County Assessor's Office, a fee totaling .06% (.0006) of the estimated value of the completed structure covered by the Insurance Company's construction policy shall be paid yearly. If land coverage is also chosen to be protected, an additional fee totaling \$1.00 per acre shall be paid yearly.

**NOTE THAT:** The owner's Insurance Company will be responsible for the validation of a physical structure on the property along with its estimated value.

### **B. PRORATED FEES**

Fees for all subscriptions entered into after October 1 of each year may be prorated quarterly. New subscriptions entered into during the last quarter of the fiscal year are required to purchase subscription service for the following fiscal year.

# C. RETURNED CHECK FEE

A twenty dollar (\$20.00) fee shall be assessed for any check returned for any reason.

**BE IT FURTHER RESOLVED THAT:** this Resolution shall replace Resolution 2-2009 in its entirety.

**AND BE IT FURTHER RESOLVED THAT:** this Resolution shall be in full force and effect upon its passage and approval.
