SUMMARY OF

ORDINANCE NO. 190

AN ORDINANCE OF THE CITY OF CLARK FORK, BONNER COUNTY, IDAHO, AUTHORIZING THE ISSUANCE AND SALE OF GENERAL OBLIGATION BONDS, SERIES 1987, IN THE PRINCIPAL AMOUNT OF \$140,000; PROVIDING FOR THE DESIGNATION, PURPOSE, DATE, MATURITIES, EXECUTION, REGISTRATION, AND REDEMPTION OF THE BONDS; FIXING THE DATE, TIME, AND PLACE OF SALE OF THE BONDS; PROVIDING FOR THE PAYMENT OF PRINCIPAL OF AND INTEREST ON THE BONDS BY THE ANNUAL LEVY OF TAXES; CREATING CERTAIN FUNDS AND ACCOUNTS; AND PROVIDING CERTAIN COVENANTS WITH THE OWNERS OF THE BONDS

A summary of the principal provisions of Ordinance No. 190 of the City of Clark Fork, Bonner County, Idaho (the "City"), adopted on September 8, 1987, is as follows:

Section 1: Authorizes the issuance of general obligation bonds in the aggregate principal amount of \$140,000 (the "Bonds").

Section 2: Provides that the Bonds are issued for the purpose of paying the costs of street improvements within the City.

Section 3: Describes the Bonds and provides for the maturity of the Bonds.

Section 4: Provides that the Bonds shall bear interest at a rate or rates not to exceed 11% or such lower rate as shall be stated in the successful bid proposal.

Section 5: Provides for the place and manner of payment of the Bonds.

Section 6: Provides for the manner and method of execution of the Bonds.

Section 7: Appoints The Idaho First National Bank as Bond Registrar.

Section 8: Provides for redemption of the Bonds.

Section 9: Provides that the Bonds shall be sold at public sale by sealed bid on Tuesday, October 6, 1987.

Section 10: Provides for publication and distribution of Notice of Sale of the Bonds.

Section 11: Establishes the City of Clark Fork Capital Improvement Fund.

Section 12: Provides for a levy of taxes sufficient to make the payments of principal of and interest on the Bonds as such payments become due.

Section 13: Establishes the City of Clark Fork General Obligation Bonds, Series 1987, Bond Fund.

Section 14: Makes provision for lost, stolen, mutilated, or destroyed Bonds.

Section 15: Provides for defeasance of the Bonds.

Section 16: Provides certain covenants of the City.

Section 17: Ratifies previous actions.

Section 18: Provides for severability of the ordinance.

Section 19: Repeals any prior conflicting ordinances.

Section 20: Provides effective date.
