

RESOLUTION NO. 7-2018
CITY OF CLARK FORK, IDAHO

A RESOLUTION PROCLAIMING THE CITY OF CLARK FORK FIRE DEPARTMENT APPROVAL TO LEAVE CLARK FORK CITY LIMITS IN ACCORDANCE WITH IT'S MEMORANDUM OF UNDERSTANDING WITH IDAHO DEPARTMENT OF LANDS AND THE MUTUAL AID AGREEMENTS WITH IDAHO FIRE DEPARTMENTS, THE SAM OWEN FIRE DISTRICT, AND TO RESPOND TO HIGHWAY MOTOR VEHICLE ACCIDENTS AND/OR FIRES.

WHEREAS the City of Clark Fork has a Memorandum of Understanding (MOU) with the Idaho Department of Lands (IDL), and

WHEREAS the City of Clark Fork has Mutual Aid Agreements (MAA) with the Idaho Fire Departments, the Sam Owen Fire District, Sanders County in Montana, and

WHEREAS the City of Clark Fork has enacted Resolution 4-2006 which authorizes the Clark Fork Fire Department to leave the city limits for Fire Suppression Subscribers, and

WHEREAS there is currently no fire protection service on the roads and highways within the immediate vicinity of the City of Clark Fork, and

WHEREAS the Clark Fork Fire Department has the capability in fire suppression and rescue, and

WHEREAS the Clark Fork Fire Department may respond outside of the city limits or outside of Suppression Subscribers area if a decision from the Clark Fork Fire Chief and his top-level subordinates determine a fire is posing imminent danger to the citizens of Clark Fork or Suppression Subscribers.

NOW THEREFORE BE IT RESOLVED by the Mayor and City Council of the City of Clark Fork, Idaho that The Fire Department of Clark Fork, Idaho is hereby authorized to leave the city limits of Clark Fork to respond to motor vehicle accidents and/or fires on the lands, roads, and highways outside of the city limits and to fulfill its responsibilities under the City's MOU with IDL and its MAAs with Idaho Fire Departments, the Sam Owen Fire District, and Sanders County in Montana.
