CARE AND CONTROL OF ANIMALS

AN ORDINANCE OF THE CITY OF CLARK FORK, BONNER COUNTY, IDAHO REGULATING THE CARE AND RESPONSIBILITIES OF OWNERSHIP OF ANIMALS; ESTABLISHING THE PURPOSE OF THE ORDINANCE; DEFINING TERMS AS USED IN THE ORDINANCE; PROVIDING REPORTING AND RESPONSIBILITIES ASSOCIATED WITH THE DISEASE OF RABIES IN ANIMALS; PROVIDING CARE AND CONTROL PROVISIONS; PROVIDING STANDARDS FOR MAINTENANCE OF MULTIPLE ANIMALS; PROVIDING DOG LICENSING REQUIREMENTS; RESTRICTING OWNERSHIP OF NON-DOMESTIC AND FARM ANIMALS; PROVIDING ENFORCEMENT AND SEVERABILITY OF ORDINANCE PROVISIONS; PROVIDING MISDEMEANOR CRIMINAL PENALTIES FOR VIOLATIONS; REPEALING ORDINANCE NUMBER 262; AND PROVIDING FOR AN EFFECTIVE DATE AND PUBLICATION.”
