AN ORDINANCE OF THE CITY OF CLARK FORK, IDAHO, PROVIDING FOR THE GENERAL HEALTH OF SAID CITY: DEFINING GARBAGE, RUBBISH AND REFUSE; REGULATING CONTAINERS WITH WHICH TO ACCUMULATE THE SAME; PROVIDING METHODS FOR COLLECTION OF REFUSE WITHIN THE CITY AND DISPOSING OF THE SAME; AUTHORIZING ENACTMENT OF RULES AND REGULATIONS FOR ENFORCEMENT AND IMPLEMENTATION OF THIS ORDINANCE; PROVIDING PENALTIES FOR VIOLATION HEREOF; AUTHORIZING INJUNCTIONS AGAINST VIOLATION HEREOF; AND PROVIDING A SAVING CLAUSE, SEVERABILITY, AND AN EFFECTIVE DATE.
