## ORDINANCE NO. 294

AN ORDINANCE OF THE CITY OF CLARK FORK, IDAHO ESTABLISHING A GENERAL PENALTY FOR ALL CITY CODE VIOLATIONS, OUTLINING MISDEMEANOR AND INFRACTION PENALTIES, ALLOWING FOR EACH OFFENSE TO BE A SEPARATE AND DISTINCT VIOLATION, REPEALING ALL PRIOR ORDINANCE PENALTY SECTIONS, DECLARING THE ORDINANCE SEVERABLE, AND SETTING AN EFFECTIVE DATE.

WHEREAS, the State of Idaho authorizes municipal corporations to enact ordinances, rules, bylaw, and regulations to maintain the peace, good government and welfare of the corporation and its trade, commerce and industry under Idaho Code § 50-302 as well as Idaho State Constitution Article XII, Section 2; and

**WHEREAS**, the City of Clark Fork has enacted various ordinances which are not inconsistent with the laws of the State of Idaho; and

WHEREAS, the City of Clark Fork strives to promote the general welfare of the city through the legal enforcement of such ordinances; and

WHEREAS, the City of Clark Fork desires to enact a general penalties ordinance to simplify the enforcement of city ordinance violations.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL of the City of Clark Fork, Bonner County, Idaho

- **Section 1.** MISDEMEANOR PENALTY: Any person convicted of a misdemeanor under the ordinances of the City shall be punished by imprisonment of not more than one hundred-eighty (180) days, a fine not to exceed one thousand dollars (\$1,000), or by both such fine and imprisonment, and, in addition thereto, any person so convicted shall pay such costs as the court may assess.
- **Section 2.** INFRACTION PENALTY: Any person convicted of an infraction under the ordinances of the city shall be punishable by a fine of \$300, and, in addition thereto, any person so convicted shall pay such costs as the court may assess.
- **Section 3.** VIOLATIONS, GENERALLY: Any person in violation any of the provisions or failing to comply with any of the mandatory requirements of any ordinance of the City for the first time is guilty of an infraction as prescribed by this ordinance. Any person who pleads guilty or is found guilty of a violation or failing to comply with any of the mandatory requirements of any ordinance of the City for a second time within five (5) years is guilty of a misdemeanor as prescribed by this ordinance.
- **Section 4.** SEPARATE OFFENSE: Every day the violation of any ordinance continues shall constitute a separate and distinct offense, punishable by the lawfully appropriate penalty as assigned.

- **Section 5.** REPEAL: All sections of ordinances which prescribe a penalty, namely the penalty sections of Ordinances 13, 17, 19, 25, 26, 65, 89-1, 93, 101, 105, 114, 115, 116, 118, 123, 130, 143, 155, 158, 164, 165, 168, 193, 209, 215, 221, 223, 231, 232, 233, 243, 277, 279, 283, 287, 288, and 291 are hereby repealed and such penalty provisions shall be replaced with those found in Section 3 of this Ordinance.
- **Section 6.** SEVERABILITY: The provisions of this ordinance are declared to be severable. If any section, sentence, clause or phrase of the ordinance shall for any reason be held to be invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of the remaining sections, sentences, clauses and phrases of this ordinance, but they shall remain in effect.
- **Section 7.** EFFECTIVE DATE: This ordinance shall go into full force and effect upon passage, public hearing, and publication, as required by law.
