Minutes of the 1/13/2025 Clark Fork Regular City Council Meeting.

Mayor Russell Schenck called the January 13, 2025 Regular Meeting of the City Council to order at 6:03 p.m.

Pledge of Allegiance: Mayor Schenck lead the Pledge of Allegiance.

Roll Call of Council Members: Sharon Banning, Tanya Becker, Jay White, and Vicki Woodward were present, constituting a quorum.

Fire Department Report:

Fire Chief Mike Schacht gave an update on the department. 2024 ended with an above normal season due mostly to high volume of calls in December. Some things that will be needing attention in the following months would be transmission work and batteries for engine 1851, looking into battery powered extrication gear for getting to vehicles located in more difficult places, and the possible purchase of an all-terrain vehicle to aide in search and rescue, off road, less accessible areas.

New Business:

A. Discussed, Quarterly Reports.

Council discussed the first quarter reports for 2024-2025 and found no issues.

B. Discussed, Century West Sidewalk Extension Plans and Cost Estimate, ACTION ITEM.

Ryan Luttmann from Century West Engineering gave an update on the Sidewalk project and presented the cost estimate for completion of the project for 2025. The plan includes connecting the sidewalks between 1st and 3rd on Main Street and continuing from 8th to 10th and terminating at Cedar. Century West estimates the job at \$283,048. Century West has applied for a grant provided by The Children Pedestrian Safety Program to cover these costs. The work that has been completed thus far was paid for through this grant program.

Council Member White moved to accept the cost estimate for the 2025 sidewalk extension plans.

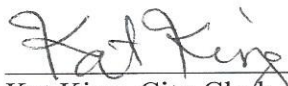
