A. Discussed, Sidewalk Extension Project Updates and Supplemental Contract Presentation, ACTION ITEM.

Ryan Luttman gave updates of the sidewalk project stating that LHTAC is requesting remaining project plans to completion be submitted by December 20<sup>th</sup> 2024, in order to be considered for grant funding. Since our project extends in to the 2024-2025 year for completion, the city needs to plan the project to completion and estimate the cost. Dan has put together preliminary plans to satisfy LHTAC and keep the city in consideration for the 2025 grant.
