Minutes of the 9/23/2024 City of Clark Fork Public Hearing

ORDINANCE 301

AN ORDINANCE OF THE CITY OF CLARK FORK, IDAHO, AMENDING THE ANNUAL APPROPRIATION ORDINANCE NO.295, FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2023 AND ENDS SEPTEMBER 30, 2024, TO REFLECT THE RECEIPT OF UNSCHEDULED REVENUES APPROPRIATION FOR EXPENDITURES IN VARIOUS DEPARTMENTS AND FUNDS, PROVIDING THAT THE TAX LEVY UPON TAXABLE PROPERTY WITHIN THE CITY IS NOT AFFECTED HEREBY, PROVIDING THAT ALL ORDINANCE IN CONFLICT HEREWITH ARE SUPERSEDED BY THIS ORDINANCE TO THE EXTENT OF SUCH CONFLICT, AND PROVIDING THAT THE ORDINANCE SHALL BE EFFECTIVE UPON ITS PUBLICATION DATE.

Council Member White seconded the motion.




MOTION TO ADJOURN, ACTION ITEM.
